**Annual Registration Fee: \$15**  
**Enrollment in the Dance Program requires the Reg. Fee plus first month's tuition on/before Sept.4th**

The 2019-20 Dance Season will run from Sept. 4<sup>th</sup> – May 13<sup>th</sup> (8.5 months) which offers 33 classes. Classes will not be held and there will be no charges for the following school holidays on **Nov. 27<sup>th</sup>, Dec. 25<sup>th</sup>, Jan. 1<sup>st</sup> and March 11<sup>th</sup>**. There will be a dance recital in **May**. Recital Date: TBA

The costume fee is **\$60** and is due by **\*Nov. 6<sup>th</sup>, 2019**

For the 2019-20 Dance Season, monthly tuition is \$45 for a 45-minute class for Pre-K3 & Pre-K4 & \$55 for a 60-minute for K-3<sup>rd</sup> Grade Dancers. Tuition is due by the first Wednesday of the month. These due dates are: **9/4, 10/2, \*11/6, 12/4, 1/8, 2/5, 3/4 and 4/1**. Please record these due dates in your calendar. If you would like to receive a reminder, please let me know. A \$15 late fee will be assessed to any late payments.
